Environmentalism and Global Warming are Christian Concerns

This week as I hear the reports coming out of the UN Climate Summit in Copenhagen, I am reminded of how precious this earth is that God has created. As Christians we are called to be stewards of God's earth. Limiting greenhouse gases, cleaning up the oceans, and recycling are part of what it means to be Christian.

Sometimes Episcopalians are surprised to hear the church speak about climate change and environmental concerns, believing them to be trendy issues that have no place in the pew or pulpit. But it might be even more surprising to learn just how very Episcopalian and Biblical these concerns are.

In one of his letters from the Episcopal General Convention this summer, Bishop Bud Cederholm wrote, "global warming (and its effects) is the most critical moral, ethical and justice issue the church faces." Lots of resolutions about caring for the environment were passed by bishops, priests, and laity during General Convention because of our Christian belief that "the earth is the Lord's and everything in it" (Psalm 24:1, NRSV).

One might also look at our own Book of Common Prayer for additional insight into concern for the creation and the environment. In the Prayers of the People, form I (p. 384) we pray "for the good earth which God has given us, and for the wisdom and will to conserve it." In form IV (p. 388) "Give us all a reverence for the earth as your own creation, that we may use its resources rightly in the service of others and to your honor and glory." In form VI (p. 392), we pray "for the just and proper use of your creation." In the Prayers of the People, Rite I, (p. 329) we pray "that, rejoicing in thy whole creation, [all people] may... be faithful stewards of thy bounty." In the Eucharistic Prayer D (p. 373) it says, "giving the whole world into our care, so that, in obedience to you, our Creator, we might rule and serve all your creatures." There is also the prayer "For the Conservation of Natural Resources" (p. 827) and the prayer "For the stewardship of Creation" (p. 208).

These issues are not new. Theologians have been writing about the importance of caring for the earth and all creatures since the beginning. For instance, St. Isaac the Syrian (685-758) wrote, "What is a charitable heart? It is a heart burning with a loving charity for the whole of creation, for men, for the birds, for the beasts ... for all creatures. He who has such a heart cannot see or call to mind a creature without his eyes being filled with tears by reason of the immense compassion which seizes his heart; a heart which is so softened and can no longer bear to hear of any suffering, even the smallest pain, being inflicted upon any creature. He will pray even for the lizards and reptiles, moved by the infinite pity which reigns in the hearts of those who are becoming united with God."

Martin Luther (1483-1546) once wrote, "Now I believe in God's Son and remember that He became man, all creatures will appear a hundred times more beautiful to me than before. Then I will properly appreciate the sun, the moon, the stars, trees, apples, as I reflect that he is Lord over all things."

The Bible itself is filled with references to the fact that the earth does not belong to us; to treat it poorly is an affront to God. Jesus came not just to redeem humanity, but all of creation: earth, plants, and animals. Some examples include Jeremiah 2:7 – "I brought you into a fertile land to eat its fruit and rich produce. But you came and defiled my land and made my inheritance detestable." Colossians 1:15-16 – "Jesus is the image of the invisible God, the firstborn of all creation; for in him all things in heaven and on earth were created, things visible and invisible, whether thrones or dominions or rulers or powers– all things have been created through him and for him." Revelation 11:18 – "The nations were angry; and your wrath has come. The time has come for judging the dead, and for rewarding your servants the prophets and your saints and those who reverence your name, both small and great — and for destroying those who destroy the earth." (all NIV)

Fortunately St. Paul's has already taken some steps to raise awareness of issues related to greenhouse gases. Last year we rang our church bell 35 times to represent the number 350. 350 parts per million is what many scientists and climate experts are now saying is the safe upper limit for CO2 in our atmosphere. The earth is currently at 390. In addition, this fall we offered parishioners the opportunity to write postcards to our political leaders asking them, as people of faith, to do more to address this issue. Churches, mosques, and synagogues around the world are joining together with the 350 movement to halt this progression of CO2. More information can be found at www.350.org/people/faith.

Love of the earth, care for the environment, preventing pollution, lowering greenhouse gases, using the earth's resources fairly with all humanity and other creatures, are not new ideas. They are as old as Christianity – even older! We are not jumping on a politically correct bandwagon, we are continuing what was begun by God when humanity was given the creation to "work it and take care of it." (Gen. 2:15, NIV). May one of our New Year's resolutions be to educate ourselves more about the threats to God's good creation and takes steps to care for it.

A Letter From Bishop Thomas Shaw on Christian Marriage

Advent I, November 29, 2009

Christian marriage is a sacramental rite that has evolved in the church, along with confirmation, ordination, penance, and the anointing of the sick, and while it is not necessary for all, it must be open to all as a means of grace and sustenance to our Christian hope.

I believe this because the truth of it is in our midst, revealed again and again by the many marriages of women and men, and of persons of the same gender—that are characterized, just as our church expects, by fidelity, monogamy, mutual affection and respect, and the holy love which enables spouses to see in one another the image of God.

In May of 2004 the Massachusetts Supreme Judicial Court opened civil marriage in our state to samegender couples. That ruling set up a contradiction between what civil law would allow and what our church's canons and formulary state, which is that marriage is between a man and a woman. And so, for more than five years now, while faithfully waiting for the General Convention of the Episcopal Church to act in response, we in the Diocese of Massachusetts have been living at some cost with an imperfect accommodation: Our clergy have not been allowed to solemnize same-gender marriages, but they have been permitted to bless them after the fact.

In July of this year, the 76th General Convention adopted resolution C056, "Liturgies for Blessings." It allows that "bishops, particularly those in dioceses within civil jurisdictions where same-gender marriage, civil unions or domestic partnerships are legal, may provide generous pastoral response to meet the needs of members of this church."

Your bishops understand this to mean for us here in the Diocese of Massachusetts that the clergy of this diocese may, at their discretion, solemnize marriages for all eligible couples, beginning Advent I. Solemnization, in accordance with Massachusetts law, includes hearing the declaration of consent, pronouncing the marriage and signing the marriage certificate. This provision for generous pastoral response is an allowance and not a requirement; any member of the clergy may decline to solemnize any marriage.

While gender-specific language remains unchanged in the canons and *The Book of Common Prayer*, our provision of generous pastoral response means that same-gender couples can be married in our diocese. We request that our clergy follow as they ordinarily would the other canonical requirements for marriage and remarriage. And, because The Celebration and Blessing of a Marriage in *The Book of Common Prayer* may not be used for marriages of same-gender couples, we ask that our priests seek out liturgical resources being developed and collected around the church. We also commend to you the October 2008 resource created by our New England dioceses, "Pastoral Resources for Province I Episcopal Clergy Ministering to Same-Gender Couples," available at www.province1.org.

We have not arrived at this place in our common life easily or quickly. We have not done it alone. This decision comes after a long process of listening, prayer and discernment leading up to and continuing after General Convention's action this past summer. Our Diocesan Convention recently

adopted a resolution of its own expressing its collective hope for the very determination that your bishops have made. Even so, we know that not all are of one mind and that some in good faith will disagree with this decision. Our Anglican tradition makes space for this disagreement and calls us to respect and engage one another in our differences. It is through that tension that we find God's ultimate will.

We also know that by calling us to minister in the context of this particular place and time God is again blessing our diocese with a great challenge by which we might enter more fully into that ethic of love which Jesus speaks to us through the New Testament. It is an immeasurable love given for all. We are being asked to live it, all of us, children of God, each with equal claim upon the love, acceptance and pastoral care of this church, so that the newness and fullness of life promised through word and sacrament might be for all people and for the completion of God's purpose for the world.

Finance Committee News

Finance Committee News

The revenue and expense for November and the first eleven months appear below. During November we

received \$17,097 in revenue and disbursed \$15,090 in expenses. For the first eleven months we have disbursed \$60,288 more than we have taken in. We did not transfer any funds from our Fidelity accounts during November and do not anticipate transferring anymore in 2009.

Looking ahead to the budget for 2010, we will still be working with a deficit budget – a deficit of about (\$57,000). Our expenses will be higher than we experienced in 2009. But income will also be higher and we expect the increase in income to be greater than the increase in expense...a good trend to latch onto. Watch for budget details with annual meeting materials.


